## Guaranty of Lease Agreement

For accepting the Monthly Installment Payment Option, I, the undersigned Guarantor, authorize the Landlord to charge my credit or debit card listed above for any balance of rent, damages, or any other charges more than five (5) days past due. If the Landlord delays or fails to give notices, make demands, or exercise lease rights, I will not consider it a waiver of the Landlord's rights. I also agree to pay any reasonable costs, including attorney's fees, imposed under the terms of the Lease Agreement or enforcement of this Guaranty.

I, the undersigned Guarantor, certify and represent that all statements and information given are true and complete, and I recognize that the Landlord will execute a Lease Agreement in reliance upon the truthfulness thereof. I authorize the Landlord to verify the information by reasonable means and perform a credit check for the purpose of this Guaranty if needed. The Deposit including Security Deposit (up to one month's rent) made by the Resident, may be retained by the Landlord as liquidated damages for any false statements contained herein.
